- Act as aerial repeater for radio communication.

The program started with Dennis Lee presenting to both Jim Buck and Penny Linterman (Program Coordinator 1, Emergency Management Division) the types of activities that pilots can do to help evaluate and recover from any type of natural or other disaster. Unlike any other presentation that Jim has given, we pilots were given some homework before his presentation. President Gene gave Jim the results of his questions to pilots that had been obtained at the Friday Safety Breakfast. After all this, Jim gave his presentation. The thing that was so neat about Jim's presentation was that unlike being confined to a time limit, Jim had plenty of time to give his whole presentation and thus the program went on for a couple of hours. The Pilots, Penny and Jim all enjoyed the informal atmosphere where pilots could ask questions and Jim could go into details that he just couldn't cover with the usual time restraints. Jim seldom has the time to present what actually happened during a practice run out at Joyce. So CCPA was treated to a more complete presentation that he usually can give. Jim feels that the role private pilots can play, especially with good communications, could prove critical. Jim also indicated to Jerry that he would be glad to come back and give a repeat performance.
