#### **Presidents Corner**

On June 15<sup>th</sup> Jim Buck will be speaking to us with a power point presentation on the Cascadia Fault Line and what would happen to the North Olympic Peninsula if a large earthquake hit our area. Jim spent an hour talking to me over the phone as to what he would like us to do. According to Jim, **planning is the key** and **our airport and its private pilots are vital.** He also stressed **radio communications** are absolutely essential. If we could do some planning during the next month, he would very much appreciate it. I sense that Jim would like our meeting held at the airport in a hangar to accompany a larger crowd. He would like us to get folks to the meeting who understand radio communications and some other emergency responders so that local folks know who might be involved. Jim also felt that FEMA cards would not be necessary (my thoughts exactly). Jim has made this presentation to communities all around the peninsula and has been asked to come back for repeat presentations. Although Jim's presentation gives a worse case scenario, it would still applicable be in part for lesser disasters.

I've lived through two large earthquakes that I felt here in Port Angeles. In the 1960's quake I was able to watch waves travel down the counter top of a bank of cabinets. I didn't know that ¾ plywood could bend that much. The danger is real.

So at our next meeting, Thursday, May 18, I will spend perhaps ten minutes or so asking a few questions so that we are better prepared for Jim's presentation on June 15<sup>th</sup>

#### WPA Protects Your Right to Fly

Large cuts in FAA and state funding of airports are in the works. It is only because WPA has responded forcfully that Washington has been as successful as it has. It is important that pilots realize that any airport could be lost if we are not on our toes.

Essentially, WPA has been extremely instrumental in countering threats to GA airports at Blaine, Boeing Field, Anacortes, Harvey, and Bremerton. All this has taken a lot of time from the pilots of WPA. To keep our effectiveness up, we need local chapters formed or local pilots groups to join WPA at Port Townsend, Bremerton and Olympia. WPA has also decided to ask all members at large to pay the full \$31 dues so that they are encouraged to either join a chapter or help form a chapter.

We also need more members to join CCPA, so if that guy or gal in the hangar next to you does not belong, tell them about CCPA/WPA. On the national level, it simply is not enough for AOPA to defend our rights. They need support from state organizations too.
