Aircraft registration late fee changes take off in 2017

Washington aircraft owners: Mark your calendars – aircraft registrations are coming due in January. For those who file late, changes are on the horizon to restructure state aircraft registration penalties in an effort to create a more efficient and user-friendly process for customers.

On July 1, a new law went into effect establishing a one-time, \$100 late fee for aircraft registrations that are 60 days or more past due. This replaces the former penalty structure, which imposed escalating penalties of up to \$400 for late registration payments.

Along with the change to penalties, the Washington State Department of Transportation has simplified its requirements for an aircraft registration exemption. Those applying for a registration exemption will no longer be required to submit hardcopy documentation along with their application. This change will allow aircraft owners to apply for exemptions online from the WSDOT Aviation website.

These changes apply to all non-exempt aircraft based in Washington for the 2017 registration year. Registrations are due every January and expire at the end of the calendar year.

Aircraft registration fees go directly to support WSDOT Aviation's airport preservation, maintenance and improvement programs, and air search and rescue operations.

AT OUR NEXT MEETING, ...at Coldwell Banker, on Thursday, November 17 we will hold a discussion and review of John and Martha's "Practical Risk Management for Pilots" After reviewing this program, which will take up 2 or 3 of our membership meetings, you will understand how to avoid emergency situations and if you get into such, how to get out of such. Come to our meeting this month and find out how Practical Risk Management will help make you a safer pilot.

Some of these guys have served ClallamCountyPilotsAssn for 15 years.

CCPA was an outgrowth of EAA/430. Around 1999 to 2000 a number of pilots understood that a majority of members of EAA/430 only wanted to "have fun with airplanes" and didn't want to be concerned with the politics of keeping our airports busy, in good condition, and a "plus" for the communities they served, etc. So a small number of pilots got together and using the EAA /430 constitution as a template, they developed the CCPA constitution.

Over the last 15 years the deterioration of many small community airports has turned out to be real with a downturn in commercial air service, private flying, use of restaurants, and the development of airport land. CCPA found it was just as difficult to find pilots concerned about the slowdown of activities at KCLM as was happening at other small airports nationwide. Even now, the majority of pilots hangered in Port Angeles are not members of CCPA. Through it all CCPA has instigated such items as a more sensible common airport frequency, GPS landing, airport fly-ins and tried to develop a better contract for the lease of hangars. But as the interest in KCLM has waned so has the interest in CCPA.

Well, enough is enough! CCPA has been unable to hold elections or inaugurated some needed changes, because the interest by pilots in KCLM is not strong enough. At our last general membership meeting only 2 pilots showed up. Jim Posner, WPA president, in the past suggested that we really didn't need to hold general membership meetings. Perhaps, Jim is right. But! if any members wish to hold an office or have input as to the level of support pilots give to KCLM, please come to our next board meeting. We need your input!
