Presidents Corner

Your executive board has tried to deal with the possible closure of the Blaine airport which is operated by the city of Blaine. WPA has asked for you to support the airport by writing to members of the Blaine city council urging them to approve the airport master plan.

At our September 13th executive board meeting, it was pointed out that there are a few problems with the Blaine airfield. Because of development, landing at Blaine has become a bit more dangerous. Because of nearby airfields, the elimination of Blaine airport would not be critical. In order to land from the north, one must enter Canadian air space. For the good of all concerned, Blaine airport could be best used for a very large truck stop and screening area for trucks that need to enter Canada. The thinking of the board at that meeting was that if an alternate spot could be found near Blaine then the old airport could be used by the trucking industry without Blaine loosing its airport.

However, at our September 21st general meeting it was pointed out by Jeff Well that his charter flight business is helped out by the Blaine airfield. It is easier and faster to walk into or out of Canada because the Blaine airport is within easy walking distance of the border than it is to drive across the border. So not only is Jeff's air charter business helped by the Blaine airport, but so are other charter businesses too. Also, it is sometimes easier to fly over to Blaine and walk across the border than it is to fly into Canada. With Homeland Security in place, Blaine field has become an important access point to Canada not only for pilots and their passengers, but possibly for truckers as well.

So at our last executive board meeting (October 4) CCPA took the position that we will oppose any decommissioning of any GA public airport especially if WPA takes that position too. However, if you would like to discuss the board's position further, then come to the general membership meeting on October 19th
