#### WPA HAPPENINGS AROUND WASHINGTON

AOPA Fly-In at KPWT (Bremerton) August 19 – 20th

According to Jim Posner this was one of the most successful Fly-Ins in Washington this year. Over 4000 aviation enthusiast attended, over 1000 cars were parked, and 690 aircraft flew in. If you count the 15 seaplanes, then 705 planes, flew in.

The event was organized by AOPA, Bremerton Pilots Assn, Washington Pilots Association, and the Port of Bremerton. The theme was to bring together "the players" in General Aviation in the Northwest to start a dialog between them. WPA acquired 23 new members at this event. Warren Hendrickson, regional manager for AOPA, gave an enthusiastic review of how we can all make a difference in how General Aviation grows and develops in the Pacific Northwest.

## WPA board meeting at Felts Field on September 17

There was a theme that seemed to be followed throughout this board meeting: That WPA is a Bottoms-up organization and that it is the board's duty to follow the will of the individual chapters and that no action of the executive board or president can be taken without the approval of the chapters. Here are some examples:

"9. Removal of personal photos and phone numbers from Marketing Materials:

The senior members of the Board reiterated the long standing policy that personal photographs and phone numbers should not be used on marketing materials. The purpose of this policy is to insure consistent contact information from election to election. A motion was made by Tom Jensen and seconded by Marian Jensen to remove all personal photographs and phone numbers.

1. WSCAA Conference, Dues, Conference and Travel Expenses


Mr. Posner submitted a request to be reimbursed for dues and expenses to attend the WSCAA conference in Leavenworth next month. The consistent position of the WPA Board of Directors for years is not to compensate Board members for travel. This is also referenced in the By-Laws.

The Board declined his request."

It is very interesting that neither the WPA president nor the two WPA vice presidents were in attendance at this board meeting.



At the last Safety Breakfast at Priscilla's it was emphatically expressed that instrument flying in IMC is not for the average GA pilot. Likewise, even if a GA pilot holds an instrument rating, it does not mean he is proficient in flying in IMC. Passengers, beware! Before flying with an instrument rated pilot in questionable conditions be sure he is proficient, like being an active airlines pilot.

These are quotes from emails I (Gene Rimov) have received on the south section of OVAL from Glenn Stehr, facilities engineer for ACTI

## September 29

. "The Port is now looking into the exact edge of the wetlands both by the terminal and the grown over road leading to Zink's Property and saddle club road. Because there is a preexisting road through that area, they think they can get an exemption for it. The wet lands by the terminal area that follows forested edge may have to be moved out since we have to be 130 feet away from the edge of the wetlands. We should hear more in the next 2 weeks. I'll keep you posted."

#### September 26

"Jesse Watkins is the environmental person for the Port. He has asked the city (Benjamin Braudrick who has control of the wet lands in that area) to review and advise.

I hope to find out the boundary area for the wet land and see if we can build just on the edge of it so that we don't have to do all the permitting and reports. If we can, then we will need to get together and review the route. If we can't then I will see what is needed from us for the permitting process."

Now our CCPA members can get an idea how complicated getting a bicycle/walking trail through the south section of our airport is.

## **CCPA Needs to Hold Elections**

Can a new set of officers help us reach our goals?

Although, we've had two themes to guide our actions, our officers have felt some frustration in informing or encouraging participation by the pilots of Clallam County and especially those at KCLM. Our two themes have been: 1) To keep our airports open, useful and viable, especially KCLM. 2) To stress safe aircraft operations.

We do have a constitution, but we have been unable to follow it because we haven't been able to hold elections. No one seems to want to run for office. Normally, we would have nominations in September, announcement of whose running for office in October, elections in November, and installation of officers in December or January. Our term of office has been two years. However, unwillingness to serve by much of the CCPA membership has meant that most of our present officers have been in office for 10 years or more. This has made it difficult to follow our themes or reach our goals.
