Anyone interested in earning their entry level, (Technician) Amateur radio license is invited to attend three classes on successive Saturdays, starting next **Saturday, September 23rd, at 9 AM** in the training room at Port Angeles Fire Department, at 5th and Laurel in Port Angeles. The classes run from 9 AM to 5 PM with an hour off for lunch.

Students will learn the Rules and Regulations, Basic Electricity, How to operate, and Radio Frequency Safety.

There is no cost for the class, which is presented by volunteers from Clallam County Amateur Radio Club. The students must purchase an American Radio Relay League Technician License Manual at a cost of \$24.95. These books are available from Tom Newcomb, who may be reached at 360-452-8228.

Those earning their license will be allowed to communicate with other hams world wide, and to participate in the Amateur Radio Emergency Service, an important part of Homeland Security. For more information, or to register for the class, call Chuck Jones, N7BV, at 452-4672 or Tom Newcomb at 452-8228.

Members of Search and Rescue, The Washington Pilots Association, Neighborhood Watch Community Emergency Response Team (CERT), and other groups are especially invited to attend these classes and earn their ham radio licenses.
