

The gas tax on Aviation fuel sales, the B&O tax on your local FBO, hangar taxes, the taxes airlines pay with each ticket sale...? Did you know that an airline that charges \$200 for an airline ticket which includes free checked bags pays more in taxes than an airline that sells the same ticket for \$150 plus \$50 in other fees? I am just scratching the surface here and will not list all the other work to do, trust me, there is plenty.

Advocacy. . . Our Legislative Agenda

It is relatively easy for a government agency to do studies and make recommendations for action but it is another thing to change the way things have always been done. The state WPA Board is asking all of us to work with them on the following items identified in the State's Airport Investment Study performed over the last few years. We hope to affect the actions taken by our government and local airport authorities to improve airport funding and infrastructures. How do you help? Read the study and use the grey matter between your ears. Then make your ideas known to the Board and start following your own ideas as well as any you read about on the WPA web site, WINGS, etc.

Establish a State-Sponsored Revolving Aviation Infrastructure Loan Fund. #4 - 1k. For those in government this program is similar to the CERB (Community Economic Revitalization Board). Airport Sponsors may borrow funds at low interest rates.

Reallocate Airport Leasehold Tax to the Aeronautics Account. #6 - 3b. Instead of property taxes airports collect 12.84% leasehold excise tax on all revenue. Check your hangar rent invoice. While a good portion of that funding goes back to the cities and counties from whence it came, the State's General Fund is also a beneficiary.

Modify the State Aircraft "Sales Tax (6.5%)" and Excise Tax on <u>Fuel</u>. #9...3d. While the Federal, Military and Commercial are exempt from the \$.11 cents per gallon, Commercial operators must pay the sales tax on fuel burned (flying) over the State.

Develop a Best Management Practices (BMP) Guidebook / **Toolkit for Airports**. **10 - 4f.** The concept entails a toolkit to help airports move toward self sufficiency in terms of capital development programs.

CALL TO ORDER

We could arrange for lodging and tour the Tulips Festival or have a clam bake. Larry will contact his friend at the museum. Tom suggested we organize another round robin event even though it was a lot of work in the past, it was still a lot of fun. We could do better at marketing the event to get more participants. We could even plan a spot landing during the fly-out to the museum.

TREASURER'S REPORT

John Smutny was unable to attend the meeting so Shane read the Treasurer's Report from John which stated:

We awarded another \$1,000 scholarship to a student at GRCC this fall and his name is Scott Barnes. We should invite all scholarship recipients over the past years to attend a meeting.

Newsletter – Tom suggested we should add a piece about current issues at State WPA level.

Auburn Airport Advisory Board – Shane wasn't able to attend last month's meeting and is looking for someone else to attend. Mike Latta offered to go. The meetings are held on the 3rd Wednesday at 7:30 am each month.

Green Tail Integration – We didn't have much communication with the Green Tails over the summer because a lot of them are out of town over their break. We need to invite them to a general meeting. We also need to send them the Newsletter. Shane has their emails.

Christmas Party & Auction – This year's Christmas Party will be on Thursday, December 17th in the Rainier Room of the Truitt Building (upstairs from Oddfellas) in Auburn. Robyn was able to secure a good deal by having the party on a Thursday and booking it was a fundraiser. We want to focus the party not only as having a good time, but also a way of promoting and generating funds for our future Scholarship recipients. Shane suggests we invite PSAAC, Green Tails, EAA Chapters, WASAR, Auburn Advisory Board, Pro Flight and asking the leaders from each organization to manage their own count of attendees.


