Laurence M. Schafer began his career with USDA Wildlife Services after earning his BS in Wildlife Biology from the University of Montana in 1997. His first position was as a specialist at Atlantic City International Airport. In 1999, he became the Project Leader for the Wildlife Program at O'Hare International Airport, where he conducted his master's research on the efficacy of



raptor translocation as a management tool. Though devastated to have to leave the soothing climate of Chicago, Laurence accepted a position as the Airport Coordinator/Staff Wildlife Biologist for USDA Wildlife Services in Washington and Alaska in 2002. While here, Laurence is dedicated to assisting airports better manage their wildlife hazards and increase aviation safety. His secondary interests are collaborating with the USDA Wildlife Services National Wildlife Research Center and other agencies to develop additional operational management tools and Wildlife Hazard Assessment techniques. If Laurence cannot be reached by phone, he's probably 40-50 miles offshore chasing Washington albacore.

Page 8 **PILOT PROFILE OF**

LARRY KAUFFMAN

I watched my cousin strap a F-102 to his backside. He then performed a max performance takeoff piercing the clear blue sky with his Delta Dagger. That was 1968. I was 10 years old; my course was set.

I was a small town Southern Idaho farm boy. I could make pretty good money shoveling ditches and milking cows on the farm. This gave me the funds I needed to get my private pilot license (Cherokee 140) while still in high school. I continued flying general aviation aircraft through college and competed with the Boise State University Alpha Eta Rho team making it to Nationals in 1980.

That same year I got a pilot slot with the Idaho Air National Guard. Here my general aviation flying faded from view. After USAF Pilot Training and F-4 school I was back in Boise a few years latter flying the Phantom II (A highlight of my Phantom days in Boise was I got to fly F-4s with my cousin, turned mentor, noted in the opening line of this missive). This was during the Reagan years so I could make a reasonable wage being a "Guard Bum." But then I became a family man and needed to find a steady job.


I worked full time at the Idaho ANG for 2 years as an Instructor Pilot in the RF-4C. Subsequently I flew 3 years for Boise Cascade Corporation. While there I flew great equipment (Lear 35, Lear 55, Hawker 800, Falcon 50) and traveled across North America flying to major airports and places I had never heard of before. In 1992 I was hired at Alaska Airlines where I was a first officer on the B-727 and MD-80 before upgrading to my current position of Captain on the B-737.

Parallel and concurrent to my corporate and airline flying I continued with Idaho ANG where I flew the RF-4, F-4E, F-4G, A-10 and C-130. During my 30 years of commissioned service with the Guard I was able to visit numerous countries on several continents. Most of these places were quite friendly while other locations I discovered there were folks who intended to do me harm. I usually responded in kind. I retired from the ANG in 2011.

At that point I had some spare time and jumped back into general aviation. I bought a 1965 C-172F with a low time Lycoming O-360 bolted on the nose. I am delighted to again be in this world of small airplane flying. I have been especially pleased to find good folks to spend time with in this sphere, of note, the WPA-GRC.







The Importance of Type Clubs

You have finally made the decision. The stars have aligned and you are going to buy an airplane. While you have decided to purchase you are not quite sure what to purchase. This depends on several factors:

What is your "mission"? Do you want to fly lazily around the area, watching the sunset or do you want to fly high and fast?

Are you interested in a taildragger at all?

Do you plan on carrying more than one passenger?

Do you want a composite, aluminum or tube and fabric style airframe?

Homebuilt or certified?

Low wing or high wing?

These are just a few of the questions you must ask yourself before making the jump.

For the purpose of this story, let's say you are interested in a classic tube and fabric taildragger for local flying and the occasional "big adventure." You would like an aircraft that holds its value and yellow is your favorite color. You have chosen the Piper Cub. Now what do you do?

This is where the aircraft Type Club comes in. Type Clubs exist to help owners, prospective buyers, pilots and enthusiasts of certain airplane types answer questions and keep these airplanes flying. For just about every airplane manufactured, there is a type club. Type Clubs are out there for 1929 WACO biplanes up through and including modern Cirrus airplanes. They also exist for many amateur built aircraft.

With a little research you find the "Piper Cub Club" is the type club for long wing fabric covered Piper aircraft. This encompasses the E2, J2 and J3 "Cub," the wartime L4 "Grasshopper," the J5 "Cub Cruiser," the PA-11 "Cub Special," The PA-12 "Super Cruiser," the PA-14 "Family Cruiser and the PA-18 "Super Cub." This is a production run from 1934 to 1994! The short wing fabric Pipers are represented by the "Short Wing Piper Club." This includes the PA-15, PA-16, PA-20 and PA-22.

Contacting the Cub Club by phone (email works as well) you will be greeted by Jamie the office manager. She is there Monday through Friday. She will tell you the benefits of joining the Cub Club for \$35 per year, including but are not limited to, six bimonthly newsletters, technical information and advice, instructor and mechanic references, specialty tool sharing, plans and technical data as well as apparel. You state you are interested in purchasing a Piper Cub and have some questions. Jamie will transfer you over to me (John Hofmann) who will be "your guide."

BOARD OF DIRECTORS MEETING MINUTES November 18, 2015 Home of Shane Mahoney – Auburn, Washington

CALL TO ORDER:

The Board of Directors meeting was called to order at 7:10 pm by President Shane Mahoney

APPROVAL OF MINUTES

Minutes of the previous meeting of September 29 were unanimously approved.

TREASURER'S REPORT – John Smutny

John Smutny provided the Treasurer's Report. There is \$4612.95 in checking and \$2012.52 in Savings. Website will be updated. No dollars have been received from the state WPA, with outstanding balance due to chapter of \$252.00. There is \$265.00 in the state scholarship fund and \$1,924.00 in the chapter Scholarship Fund.

We have received dues from 11 new members in 2015. The membership list has been updated.

OLD BUSINESS:

- **Newsletter publication**: The Newsletter will be published by Robyn Mahoney on November 25. A notice about the December 17 WPA Party will be included. Newsletter needs to be sent directly to Kevin for WPA newsletter publication. Marion is requesting information from Chapters to include in the state newsletter.
- 2. Auburn Airport Advisory Board: The November meeting was cancelled today. Meeting is held every other month. Mike Latta attended the meeting in August and reported that there was a lot of energy to promote the interests of the Auburn Airport exhibited by board members. The city will be putting out to bid the future management of the airport. The airport is currently making money for the city. The airport is currently closed for re-surfacing of taxiways and runways. The request previously presented by Mike Latta for discounted fuel prices for Angel Flight was denied.
- **3. Green Tail Integration**: Curt Scott announced that he has retired from Green River College. He introduced the new Faculty Advisor for the Green Tails, Coleman Boettger. Coleman joined WPA during the Board meeting. He was encouraged to consider joining the Board as a Member at Large. A new idea was brought forward related to integration by Curt Scott. He suggested a Saturday afternoon event to include Green Tails in informal conversation with aviators at someone's hangar for discussion of basic aviation topics. No action was taken on this idea. Next integration activity was identified as initiation of Green Tails to the WPA Christmas Party.

Action Items:

Coleman was asked to take flyers back to school and promote the event.

One week from meeting, board members were asked to send ideas for Green Tail integration to Shane.

Board members were invited to a Green Tail event at Coleman's on November 20 at 1:30 at Coleman's home.

4. Scholarship Awards: There are no scholarship issues for this meeting. There is currently money for one scholarship. The hope is to make enough money from the WPA Christmas party for a second scholarship. There was discussion of idea that the WPA Board wanted to get names from the schools and select individuals for scholarships. It was clarified that the WPA Board can make the recommendation; however, the school determines who is awarded the scholarship. The awarding of the scholarship for 2016 will be done in the spring.

NEW BUSINESS:

State WPA Board Meeting Report: Tom Jensen and Shane Mahoney attended the state WPA Board meeting. They reported that there was significant discussion of standardization of activities of the various chapters. Same logos are expected and literature was distributed to demonstrate expectations of standardization. There was also a discussion of cash flow and the need to promote new memberships. President John Dobson is attempting to upgrade the WPA management system, in particular the on-line communication system. The system is in need of upgrading. The old system was hacked and had to be shut down.

Action Item: Curt Scott was asked to write an article about GreenTails and their ongoing relationship with the Green River Chapter of WPA, and include information about the recent scholarship award. The article is to be submitted to state WPA for publication in their newsletter.

- **Logo Wear:** Laurie Johnson continues to work on getting various items available with Chapter Logo, as approved by state WPA.
- **WPA Christmas Party:** Scheduled for December 17 at 6 pm, upstairs above Oddfellas in Auburn. Robyn shared the flyer that was prepared for distribution and board members made suggestions for revisions. It was suggested the Flights Over Pacific Northwest Facebook page should be used as a place to advertise the event. We need an attendance of 110 to be on par with what we did last year. The restaurant has discounted food substantially in support of this charity event. There will be a no host bar. 65 people are needed for event to break even.

Action Items:

Auction items are to be taken to Shane's hangar. Further planning for party will take place after the close of the Board Meeting.
