Flight restrictions will be in effect from January 29, 2010 thru March 24, 2010. Please remember to check NOTAMs often and fly informed!



VFR flight plans for flights departing, arriving or transitioning the 30nm radius Olympic ring must be filed with a NAV CANADA Flight Information Centre or a FAA Flight Service Station. Flight plans filed with DUAT(S) providers in Canada or the USA do NOT meet security requirements of the 2010 Winter Olympics.

hit. I saw quite a few of our Chapter Members there and all seemed to be enjoying themselves. There were over 200 vendors and the presentations were really informative.

At lunch John Dobson our WPA State President gave out our State awards and also gave us an update on the situation in Olympia. The situation with the Excise Tax on our Airplanes is still grave. We all need to make sure we have written to our State Representatives, and let them know how we feel about this onerous bill – (having legal obligations that outweigh the advantages. "House Bill 3176 (Part 10 on page 69) will destroy aviation as we know it in this state" – John said.

Basically, the Legislature is proposing in Part 10 that we as aircraft owners pay .5% (1/2%) Excise Tax every year based on the aircraft's value. A \$50,000 Cessna 172 would pay \$250 every year. A new \$225,000 Cessna 182 would pay \$1,125 every year. Guess what a corporate jet would cost? What about the flight schools? And they get to decide how much our planes are worth. Everyone needs to be aware of this and let our State Government know that we are against it.

Olympic TFR. The 2010 Olympic Games TFR is now in effect in Northwest Washington State! All pilots are requested to obtain a complete preflight briefing from FSS prior to operating in the vicinity of the TFR. Pilots should request the complete NOTAM information concerning the TFR and the airport specific transponder codes from FSS, DUAT(S), AOPA or other approved flight planning service prior to flight near the TFR. Fringe airport transponder codes have been established for VFR operations at seven airports that are located in or near the TFR. These airport specific transponder codes provide advance warning to ATC monitoring the airspace of your intention to land or depart one of the fringe airports under VFR. Compliance with the TFR and NOTAM is mandatory by all pilots. Non-compliance by pilots could result in further airspace restrictions. Our Chapter Membership is still only at about 50%. If you have forgotten to re-new your WPA Membership, please try to do it ASAP. Please call any of our Chapter Officers if you need any help doing it online or off. Thanks so Much and Keep Flying Safe.→


