us up to speed on the NASCAR proposal near Arlington. He followed up at the Board Meeting elaborating on several of his points. In essence the facility (if built - south southwest of the airport) would fall under prevail of the TSA and that means Temporary Flight Restrictions. One way to minimize the impact is to add a temporary tower during such events . . . similar to the Northwest EAA fly-in in July. NASCAR is much more popular on the east coast. This sounds like a no-brainer. The county gets a great venue (NASCAR) and economic growth. They also get some desperately needed attention to their infrastructure. The only downside is to the pilot community. We would have to adjust to a TFR and temporary tower once or twice a year. Who are we to say NO to something that could be a major benefit to our community?

Reality sets in when we ask some questions. Just how many NASCAR events would happen during the year? The temporary tower would be in effect from when to when. Are we talking just for the event (several hours) or are we talking several days? What procedures would be in place for NORDO and ultra lights? Is there any benefit (long or short term) to GA? How many aircraft fly in to support a NASCAR event? AOPA did an expose on the traffic flow for such events a couple of years ago . . . this is serious stuff!

The issue to me is trust. The City of Arlington has not proven to be a stellar defender of GA assets. Remember, this is an airport that has received federal funds and must abide by that federal agreement. They also threatened to encroach on the Northwest EAA fly in several years ago by developing airport property used by that group. In my view the City of Arlington has not given full consideration to the airport as a major community asset. It is just not part of their long tern strategic plan.

Another issue is the political process that now surrounds the TFRs. We have analyzed to death the technical side of the four TFRs about Puget Sound. The admiral's assistant tried to defend the Navy's actions in Puyallup yet did not understand the difference in Kinetic energy of a C152 and a Boeing 767. Even though there has been a marked reduction in their size they are still in place because of the personal bias against GA by one person.

For me to support NASCAR the City Fathers in Arlington need to address their issues of credibility with GA. They need to figure out a way to remove the politics from the assignment of TFRs. And, they need to understand that aviation is a technical discipline that responds well to facts . . . all of the facts.
