### October Program Review:

Our last dinner meeting at O'Donnells for the year found us feasting on steak and salmon. Sandy Allen won the free dinner. We were entertained by representatives from Oregon Aero, based in Scappoose, OR. They gave insight into the beginnings of a very successful company that has expanded from their first product, the SoftTop, to products that encompass more than aviation.

#### Greetings from the dry lakebed at Edwards Air Force Base (Mojave California).

Today October 1st, 2010, Edwards' Test Flight Nation held its 1st Civilian "Fly-In" to bring the flying community together, and to promote safety of flying in and around Military restricted airspace.

It was a real pleasure to be here and to see all these (100) civilian air planes parked out here on the dry lakebed. Military personnel said it was a first, and a beautiful sight to see so many planes on the dry lakebed. There were over 2000 applications filed to fly here, but only 100 were privileged to be drawn by lottery to attend. The farthest was from Connecticut.

The dry lakebed was very interesting to witness firsthand (see my photo link below) as planes touched down on this "holy grail" of air strips. It was like standing on the "top of Everest" to be here for many who attended, myself included. The lakebed varied in consistency in size of the dried patches of clay/dirt, but the texture was similar overall. There sure is plenty of room out here for just about anything.

General David J. Eichhorn (Commander of the base) led off this event with a wonderful history of Edwards along with multimedia presentation of Edwards' best test flight program, the "X-15", which still holds the fastest

(Mach 6.7) and highest (370,000 feet) for any air/space plane to ever fly.

Later, we all had a presentation on how to best navigate and operate aircraft in and around Military restricted airspace, such as Edwards. It had some good points and great info.

Lunch was then served, and then all had a chance to meet and greet, look at airplanes, along with some fly-by's, with the F-22 breaking the sound barrier. Oh, I know I'm in aviation heaven now! Great Stuff.



He shall be an ex-officio member of all standing committees of the Chapter, sign all official documents, counter-sign all checks unless waived by the President, appoint all committees, and perform such duties as are required of this office.

<u>Section 2- Vice President.</u> In the absence or disability of the President, the Vice President shall exercise all powers and perform all duties of the Office of the President. The Vice President shall act as parliamen-

tarian at all Chapter Meetings.

<u>Section 3 – Secretary.</u> It shall be the duty of the Secretary of the Chapter to keep the minutes of all the meetings. The Secretary shall attend to the giving and serving of all notices of the Chapter, handle all correspondence, and is custodian of all documents and records, and shall keep a current list of all members. **Nominee: Karen Reid** 





<u>Section 4 – Treasurer.</u> The Treasurer shall notify all members when dues are payable and receive all monies. The Treasurer shall notify the Membership Standing Committee Chairperson who will notify the applicant for membership of their election or rejection. The Treasurer shall give receipts for all monies and deposit same in the name of the Chapter in such repository as shall be selected by the members. The Treasurer shall keep correct records of the financial affairs of the Chapter, making monthly reports of said finances, have custody of all funds belonging to the Chapter and disburse same as authorized by the members. The Treasurer shall collect all annual dues and issue proper receipts to the members. He shall remit to the State Secretary or Treasurer within thirty days after receipt, appropriate dues together with the current name and address of each member paying dues and a statement as to whether each member's dues are for a new or renewal of membership.
