President's Message by Steve Waterman

I hope everyone enjoyed their holidays. It's a new year and I am excited to take the helm of our pilot association from which I receive a great deal of enjoyment.

I am a fairly low time pilot receiving my private pilot certificate in May of 2005. I currently rent but just began construction of an RV-7A. I have been active in the WPA for six years. I thought it would be appropriate to invite the members to share with me what they would like to get out of their membership in the WPA. A good start might be to share with you the



results of a survey conducted by our past president Les Smith a few years ago. At that time he received responses from 45 members. That seems to be about the number of members who participate in many of our meetings and some of our other activities. He asked out of our four main areas of activities, which was most important. Advocacy came in first, followed by education, social activities, and outreach. When asked about the most important chapter activities, the top three responses were seminars, political involvement, and General Aviation Day. 70% of the responders indicated they were satisfied with the organization. 76% responded that they had been to a general meeting. When asked if they wanted more of a voice in what the WPA does, 88% said no. We have about 200 members in our chapter. If people are joining and lending their financial support to our group for our political involvement or public outreach programs then I am obligated to support their wishes.

Our former state president John Dobson will be keeping a close watch on things for us in Olympia. Our former chapter president Les Smith will be keeping in close touch with John as well as doing his own information gathering and contributing a regular column in our monthly newsletter. We will also send out time sensitive emails as important issues arise. We will continue doing events like General Aviation Day, Aviation Academy, Science of Flight for Teachers, and providing Aviation Scholarships.

Our outreach programs take a lot of people power. We are seriously short of volunteers for many of our programs. We will continue to bring interesting programs to our general meetings but for now we do not have anyone to head up our Safety and Education Programs. The Harvey chapter has an active Saturday seminar program and we are welcome to join them. I will make sure the schedule is posted on our website.

My particular slant is toward social activities. One way to expand the scope of activities is to combine efforts with other chapters like Harvey and Arlington. I plan to involve them in our events and get word of their events to our members. I love the Saturday fly outs and hope that we can have the other chapters

join us. I believe that members will get more out of our organization if they get involved. I invite you to join us in a new activity and get involved with running the chapter. All members are welcome to the board meetings which are generally held on the Thursday night before the general meeting at 6:30 at the Paine Airport office. We usually go out for dinner afterwards. Welcome to a new item in the chapter newsletter. Our new chapter president, Steve Waterman, has requested this new feature. The four pillars of WPA are Advocacy, Outreach, Education, and Social Activities, and we each have our own opinion of which is most important. While there are many opinions, one could suggest any one of the pillars to be the most important at a given time. For this column, yours truly will deal with Advocacy. Since WPA focuses on state issues, I'll try to do the same, but some issues at the national level deserve our attention as well.

The special legislative session, in Olympia, appears to have concluded without affecting the cost of aviation for us in Washington. There is little doubt that the new 2012 session, which convenes January 9th, will find its way to reconsidering how we "rich pilots" can be called upon to contribute greater revenues (in other words, taxes) to the state. With that in mind, the WPA State Board voted to contribute \$1,000 in support to WAMA (Washington Airport Management Association) with the lobbyist they have retained for work in Olympia. This lobbyist has successfully served WAMA, The Washington Aviation Coalition and WPA well over the last two years and the Board felt it appropriate to put a little skin in the game.

So, enjoy your holiday and be prepared to lock and load for a communication campaign with our

State Legislature in 2012. Just as your vote counts, so do your letters, emails and phone calls.

Meet your 2012 Vice President Vera Martinovich





>> How and when did you get interested in or into aviation?

I thought airplanes were cool as a kid growing up in rural Iowa, but I thought the only way you could fly them was to go into the military. With poor eyesight and a bout of Hodgkin's lymphoma at 14, I didn't think it would happen. So I went into aerospace engineering instead. I finally realized flying was something mortals did, too, and got my private pilot certificate at age 38.

>> What aircraft have you owned and if you own one now what model?

My husband and I own a 1974 Cessna 150 Aerobat, a 1969 E33C aerobatic Bonanza, and a 1961 95-55 Baron. The Bonanza was his before I was, and there has been some good-natured debate about which one of us is the wife and which is the girlfriend.

>> What non-owned aircraft have you flown?

I teach at Regal Air, so I fly their stable of Cessna and Piper products. I have flown Aeronca Champs, Luscombes, Decathlons, various floatplanes and hullplanes, and even a Tiger Moth at a grass field in England. I just got my B-25 type rating at Historic Flight in Mukilteo, and I participate in their ride program. What a hoot!

>> Are you involved or have ever been involved as a volunteer in any other aviation related organization?

I am a Young Eagles pilot with EAA and have flown animals for Pilots n Paws. I have volunteered at the International Aerobatic Club displays at Oshkosh for several years now. I have also been very involved in the American Institute of Aeronautics and Astronautics as local and national chair of various committees.

>> What is/was your career?

I have been at Boeing for over 23 years, mostly in aircraft handling qualities and flight control design on fighters, helicopters, and commercial transports. Currently I am in Flight Deck Research, working on new displays and cockpit environments for future commercial airplanes.

>> What inspires you about aviation?

Learning. Every type of flying I try, from aerobatics to water flying to formation flying, makes me a better pilot. You can't ever know it all, but you'll never get bored and there are always such helpful people around to support each other. I also enjoy teaching and sharing my experiences in aviation.

>> Why are you a member of WPA

I joined to support local aviation, but I remain a member because of the wonderful people and good friends I've made. Dinners with Chef Becky don't hurt, either!

>> Anything else of interest would you would like to share?

My husband and I had our first date in the Museum of Flight's 247 on a trip to the Arlington Fly-in, got engaged in a B-17, and got married in the North 40 campground at Oshkosh. And you should see the airplane decor in our house! Flying and aviation are very big parts of our lives. Another hobby I have is sewing. I'd like to start a side business making airplane art quilts or machine embroidery. In my "spare" time, I am also the head instructor for the Boeing Employees Taekwondo Club.


