Legislative Activities

In Olympia,

House Bill 2244 passed by House and Senate, awaiting the Governor's signature.

House Bill 2089, which calls for a one percent excise tax, is languishing, awaiting assignment to committee.

In Congress,

House aviation subcommittee Chairman Tom Petri (R-Wis.) on March 1 fired off a letter bearing 195 congressional signatures (versus 118 last year) to President, reminding him that user fees have been proposed by presidents of both parties but were overwhelmingly defeated each time. This was in response to a user-fee proposal appears in the White House's 2013 budget package. That's nearly half of the House, and a majority would very likely oppose the measure, if it were to make it to the House floor for vote. The Senate Caucus is now circulating a similar letter for signatures.

In other aviation news,

The NOAA ruling on Marine Sanctuaries went into effect this past Monday. I had a conversation with folks from AOPA about how we should proceed. Their guidance is that we should await a response to the AOPA/EAA joint letter. They also advise that we remain on standby for a letter writing campaign. Further announcements will include where those letters should be directed. (such as perhaps NOAA Asst. Administrator; FAA COO)

Politico.com reports that an unnamed Defense Dept. official urged his colleagues to "synch up" with the GPS industry back in 2010 to defeat LightSquared's proposed cellular communications network. The e-mail, if authentic, would bolster LightSquared's claim that it was the victim of a coordinated attack by government insiders and the GPS industry. The political news site said it received a copy of a Dec. 29, 2010 e-mail in which the official said Defense needed to coordinate its efforts with the commercial GPS industry before the National Telecommunications and Information Administration began to study the question of whether LightSquared could coexist with the navigational system.
