Land use conflicts continue around GEG

On November 22nd, Larry Krauter and Ryan Sheehan from Spokane Airports and I testified before the Spokane County Commissioners against a requested zone change for about 7.7 acres near the approach path of runway 21 at Spokane International Airport (KGEG).

The property is on the south-west corner where US 2 and Geiger Boulevard cross. The current zoning is light industrial. The owner wants to change to a mixed use designation, which allows for permanent residences. The City of Spokane and Spokane County are in the process of adopting the guidelines for land use within the FAA overlay zones. The property owner previously submitted a zone change request to the Spokane Planning Commission and was denied. The owner has appealed that decision to the County Commissioners, which they did on November 22nd. The Commissioners will rule on the request at their December 6th meeting.

These types of battles are getting more frequent and will continue. The management at Spokane Airports has been very wise to acquire ownership of a lot of property around the airport. We all have seen what happens when unrestricted growth is allowed to encroach around airports. Along that line, John Townsley forwarded a link to an interesting article in the Los Angeles Times about the Santa Monica airport: www.latimes.com/news/local/la-me-santa-monica-airport-20111126,0,2756011.story.

When leases expire in 2015, the City of Santa Monica says it won't be obligated to operate the facility as an airport. The FAA disagrees, standing with pilots and passengers. Foes cite noise, pollution and plane crashes. This is a perfect example of what happens when residential property is allowed to encroach on valuable airports.

The worst encroachment I have seen is the approach into the Caracas, Venezuela airport. The airport is located on the Caribbean coast with lots of high rise buildings. I don't know what the minimums are for the ILS but the airplane is level with a lot of buildings on the approach from the north.


Washington Pilots welcome back to Henley Aerodrome....To play
