Air Traffic Control is the topic for the next Spokane Chapter meeting on Wednesday, November 17th at 7:00 p.m.

We've moved our meeting out to Spokane Airways at Spokane International Airport on the general aviation side.

Approach Control is our guest speaker. He will discuss the Class Charlie airspace around GEG and how best to make a VFR transition. From there the discussion will progress to how to transition "Bravo" airspace, like Seattle. He will review what is expected and a few of the rules. From there the discussion will go to IFR procedures, practice approaches, plans to integrate

GPS approaches, and much more.



Then Mitch will tell us a few horror stories, such as- "This pilot calls up on the radio and says blah blah blah," and how they deal with these situations. So bring a few "intelligent" questions.

Our hosts will be Spokane Airways, at 3910 S Davison. To get there, take the Geiger Blvd exit off of I-90. Go straight across Geiger into the business park and follow the signs.

In the "Airport Overlay Zone" by John Townsley

The City of Spokane owns Felts Field and is in the process of annexing lands around the international airport. Part of this process is creating airport overlays and protective zoning around Spokane International Airport (GEG) and Felts Field (SFF).

Proposed zoning would prevent future "incompatible land uses" near the airports. Land uses, such as schools, hospitals, day care facilities, residential areas, and other developments where people congregate create controversy that constrains airport operations and often results in airport closure. Proposed zoning would affect undeveloped land around GEG and SFF, and prevent redeveloping existing developed land in ways that would create a hazard to aviation. The City is the 'lead agency' for airport zoning and overlays for SFF and GEG. Other cities and Spokane County will follow the City of Spokane's lead as they update and amend their own zoning. The Spokane City Planning Commission will consider the proposed zoning and airport overlays on Wednesday, November 10th at 6:00 p.m.. The process of creating airport overlays and airport zoning will take over a year.

Who would have imagined that Blaine Municipal Airport would close? Even large, well established airports like Meigs Field in Illinois closed. Good zoning is our best hope to keep SFF and GEG viable. Pressure to limit airport operations builds with every new residential plat, new neighborhood, and new day care center.

What can you do to keep SFF and GEG healthy and viable? Contact Louis Meuler (lmeuler@spokanecity.org) or Kathleen Weinand (kweinand@spokanecity.org) at the Spokane Planning office. Explain that you favor strong zoning and airport overlays to preserve Spokane Felts Field and Spokane International Airport because it improves safety for aircraft and for people on the ground. It also minimizes noise complaints. Tell them you believe zoning and overlays "are" the right thing to do.



IDAHO HAPPENINGS



Curtis Pusher takes to the skies by Geoff Beth

J.J. Ward piloted the first powered flight over the Lewiston/ Clarkston Valley on October 13th, 1910. Now, 100 years later, the 1909 Herring-Curtis "Model- D Pusher" flies once again, looking and flying just like the



original at first glance, then look again; the O-200 engine, sturdy wheels capable of cross-wind hard surfaces, and rudder pedals? It's better. (Certain "modern day" amenities incorporated to meet current FAA standards).

Built by Jim Otey (former WPA president & Boeing engineer) and recently inducted EAA-Hall-Of-Famer Dean Wilson (inventor of the Avid-Flyer aka "Kit Fox"), the brittle, yellowed plans were discovered in a widow's attic and brought to the EAA. They soon discovered they were the wing-forms for the first aircraft ever flown in Idaho! The Glenn-Curtiss museum shipped copies of the original plans for \$25. After 1,400 feet of rigging, spruce, bamboo tubing, cloth doping, and two years later: The 724pound, bi-winged, four-stabilized "Header" was officially rolled-out under a governor's-proclamation for the "IDAHO CENTENIAL OF FLIGHT" at Lewiston airport's Stout Aviation.

How does it feel to learn to fly a plane you've never flown before? "With that 80 horsepower, C-150 engine, the minute you apply power, you better be ready to start flying," Otey said. "Curtis would most certainly have approved of this remarkable 400 foot take-off in five seconds and subsequent climb-out at 55 mph. With 260 square feet of wing at 4 pounds per foot loading, it flies more like a glider than a Champ... but you wouldn't want to try and glide it," Jim adds. "My stomach isn't so tight anymore. I think it's growing on me" Jim admits, as he rolls down RWY8 at KLWS beside two PBS-TV camera trucks.

As for the future: There are several offers to house it at several area museums and even an invite for the US Navy 100 year anniversary.

New chart product coming in February

On February 10, 2011, the Federal Aviation Administration (FAA) will make available a new product, the U.S. VFR Wall Planning Chart. This new product will provide users with a single chart of the contiguous United States that aids in planning and charting a course of VFR flight across large areas of the country.



The aeronautical information includes airports, radio aids to navigation, Class B airspace and special use airspace. The topographic information includes city tint, populated places, principal roads, drainage patterns and shaded relief. The scale of the U.S. VFR Wall Planning Chart is 1:3,100,000, the size is 59x36 inches flat, and it is updated annually. Expiration date clarified for aircraft re-registration

The FAA clarified the expiration date for re-registered Certificates of Aircraft Registration in an Oct. 12, 2010, memo. New regulations require aircraft owners to re-register their aircraft over the next three years and renew the registration every three years thereafter.

The first re-registration notices were sent on Oct. 1, 2010, for aircraft registered in March of any year. Registration certificates for those aircraft will expire on March 31, 2011. However, once an aircraft owner submits his or her re-registration application and is issued a new certificate, that certificate will expire three years from the month it was issued regardless of when the original certificate was set to expire, e.g., a certificate originally due to expire in March 2011 that was re-registered in January 2011 will expire on Jan. 31, 2014.
